REGISTRATION INFORMATION

Texas Rollergirls Rock-n-Rollerderby® proudly presents the Texas Rollergirls Junior League, aka the Austin Derby Brats. This junior flat track derby program, open to girls ages 8-17, represents the future of women's roller derby. The Texas Rollergirls are excited to train the next generation of roller derby athletes!

The primary focus of the Texas Rollergirls Junior League program is to develop character, confidence, leadership and social interaction in girls through sports, and the Austin Derby Brats believe that performance is secondary to these ideals. The Austin Derby Brats intends to nurture and develop both skilled athletes and those who have not yet realized the champion inside of them.

We subscribe to the following governing principles:

1. Safety
2. Sportswomanship
3. Full Participation (everyone gets to play)

Age Groups & Requirements

Skater shall be 8 years old on or before the first week of the 10-week session to be eligible to skate with the Texas Rollergirls Junior League.

- Elementary school (ages 8-10)
- Middle School (ages 11-13)
- High School (ages 14-17)

Due to special circumstances, changes could happen within the age groups. Skaters who are young for their grade level or who are small for their age could be placed in different age categories.

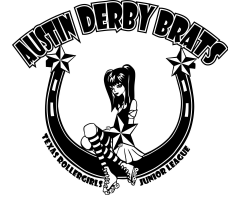
Practice & Scrimmage Information

- The registration fee covers the 10-week session that starts on September 10, 2009 and ends November 20, 2009.
- Practices will be held:
 - Thursdays from 7-8pm @ Millennium Youth Entertainment Complex (MYEC)
 - Fridays from 6-7pm @ Playland Skate Center
- Scrimmages will be held from 7-8:30pm at MYEC on:
 - October 8, 2009
 - October 22, 2009
 - November 19, 2009
- In order to participate in practices and scrimmages, skaters must wear all necessary equipment.

Registration Fee and Insurance Coverage

- Each skater will pay the registration fee of \$90.00. The cost of equipment is not included in the registration fee. No refunds.
- Registration is due by the 4th practice, September 18, 2009.
- Each skater should have primary insurance, have paid the full registration fee, and signed the insurance waiver in order to participate as an Austin Derby Brat skater.
- Secondary insurance will not be available to skaters.
- The junior league program is not currently under any insurance plan. Please discuss with the managers if you have any questions or concerns.
- Installment plans are available upon request. Please contact the Junior League Management.
- Registration fee may be waived per the Texas Rollergirls Junior League Scholarship.
- If a skater is offered the opportunity to play at tournaments or championship games for the Women's Flat Track Derby Association (WFTDA), all spectators/parents could be charged admission to the games.

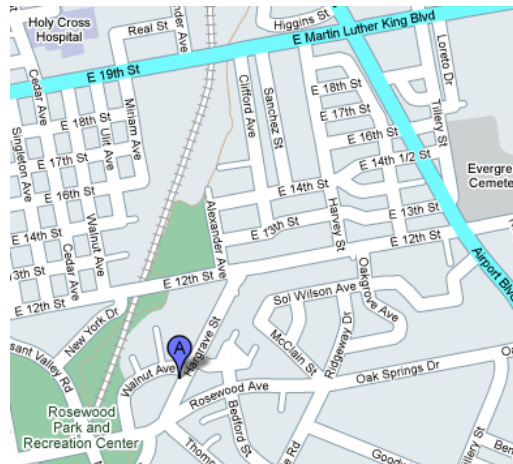
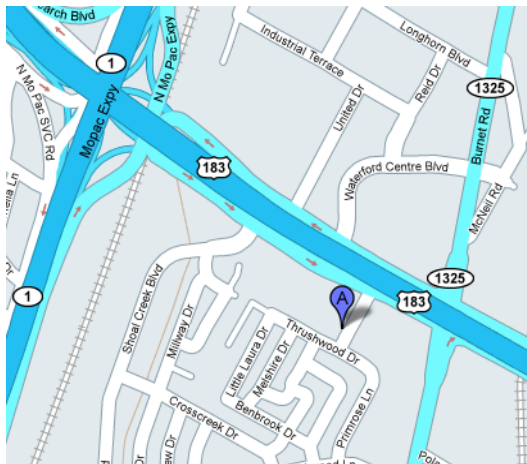
- Management of the Texas Rollergirls Junior League will consist of three managers - two parents/non-competitive adults from the Junior League and one liaison from Texas Rollergirls.
